The volume of foreign direct investment into the Czech Republic rose by about 130 % to approximately CZK 113bn last year, according to the report of the UN Conference on Trade and Development. In comparison with the countries of the Visegrad Four, the Czech Republic was surpassed only by Poland, where amounted investment to approximately CZK 161.5bn. In 2010, Czech firms invested about CZK 28.4bn abroad. Czechlnvest provided the information.

Δ Letohrad-based manufacturer of circuit breakers, OEZ, plans to open a new factory in Kraliky next year. The company, which is a part of the Siemens group, will make a new type of fuse in the plant. The expansion of production will offer 130 new job positions. According to Siemens' spokesman, Pavel Kaidl, the company also plans to end the production of the fuse complementary program in Vyprachtice. The local staff will be offered jobs in the other OEZ plants.

• **Brembo Czech** has asked for the environmental impact assessment for the production of aluminium parts and sets of products for the automotive industry in the industrial zone CT Park in Ostrava-Hrabova. The project includes smelting furnaces with a daily output of the liquid aluminium production of 20 tonnes. The intention is being assessed by the Magistrate of the City of Ostrava. Source:

Austrian company Gallai & Wolff is asking for the environmental impact assessment for its intention to build a new plant in the municipality of Klenovec for EUR 10 mln. The new plant will likely jobs. The offer 253 new will construction likely be commenced this year. The investor intends to produce first bridge bearings in the new plant in the first quarter of next year.

• An Austrian producer of products made of concrete Semmelrock Stein+Design Dlažby is asking for the environmental impact assessment for the intention to build a plant producing concrete paving in Pohorelice. The plant will likely produce lock paving, kerbs, products for gardens and other construction parts. The annual capacity of the plant will likely reach 123,000 tonnes.

• The firm Lettenmayer a Partner has asked for environmental impact assessment for the project of the Jirkov Industrial Park near Chomutov. The territory will be divided into two locations. Sector A – North will be sized 213,635 sq m, while Sector B – South will occupy 65,557 sq m. The entire facility is designed for wholesale warehouses and administrative buildings for one or more tenants.

• **CTP Invest** is asking for the environmental impact assessment for the intention to build two new buildings E2 and E3 in the industrial zone Cernovicka terasa in Brno. The total area of the intention will reach about 60,310 sq m. The buildings will likely provide space for approximately 1,350 employees. The construction will likely begin this year and end in 2013.

The intention of Valbek to build an expedition and logistic area of Kamax in the industrial zone Turnov-Vesecko has passed the environmental impact assessment by the regional authority of Liberec Region. The project is invested by Kamax. The area will likely provide space for up to 1,000 employees. The builtup area of a manipulation and warehouse hall will reach 43,882 sq m. The construction will likely be commenced in August and completed 16 months later.

Chladek Tintera. а Pardubice asks for the EIA assessment of its plan to build a logistics and distribution complex in Pardubice. The object should be used for logistics and should serve as an intermediate shipment storage. It will have 410 employees. The start of the construction is expected in the next year and the completion in 2013. Pardubice District Office is now assessing the plan.

Some 136 employees are expected to work there. The implementation should start this year and the completion is planned for 2013. The total built-up area is to exceed 34,000 sq m.

On July 19 the European Commission approved the allocation of EUR 244 mln for 183 projects in the framework of the Life+ programme from the Environment Protection Fund. The projects are focused on the protection, environment environment policy and administration or information and communications. The Czech Republic was able to win EUR 2.8 mln for the ReStEP project. which is focused on the procession of the methodology for the municipal and regional development planning with regard to the energy sustainability, and the Medetox project, which will assess the rate of toxicity of fuel mixtures exhalations and their impact in health of inhabitants of Prague.
