

1. European Union Funds 2007-2013

In the programme period 2007-2013 the Czech Republic has available EUR 26.69 billion from European funds. In order to achieve the objectives and priorities defined in the National Development Plan and National Strategic Reference Framework, the Czech Republic has prepared 26 operational programmes for fulfilling the three objectives of the European Economic and Social Cohesion Policy:

Objectives: 1) Convergence



2. The Operational Programme Enterprise and Innovation (OPEI)

The Ministry of Industry and Trade of the Czech Republic approved the framework of the Operational Programme Enterprise and Innovation and 15 grant programmes for the period 2007-2013.

3. Aid recipient

An aid recipient within OPEI can be a small or medium-sized enterprises (SME); in some programmes (depending on the particular call for proposals) large enterprises with more than 250 employees can also apply for aid¹. The project must be implemented within the Czech Republic, outside the city of Prague (the seat of the company can be located anywhere in the Czech Republic). In some programmes universities, municipalities, districts and other institutions can also be applicants.


The amount of the subsidy for eligible costs is governed by the Regional Map of State Aid Intensity.



Applicants must be permitted to conduct business in the territory of the Czech Republic corresponding to the aided economic activity, for which the project is being implemented. Furthermore, applicants must be registered with the tax office as an income tax payer pursuant to Section 33 (1) of Act No 337/1992 Coll., on the administration of taxes and charges, as amended, i.e. uninterruptedly for a period of no less than two closed tax periods preceding the date of the submission of the aid application (two years history).

In cases of particular calls for proposals, the two-year history can be substantiated by a parent company:


Another important criterion is that any project implemented within OPEI must be implemented in the manufacturing industry according to the sectoral classification – generally in the sectors CZ-NACE 10-33. However, this criterion depends on the particular programme and call for proposals.

4. Process of applying for provision of aid and project evaluation

Applications for the OPEI grant programmes are submitted in two steps (Registration Application and Full Application) via the eAccount internet application, which is only in the Czech language. The eAccount application can be accessed via http://eaccount.czechinvest.org.

- I. Successful registration requires a qualified certificate (electronic signature), which is available at Česká pošta, s.p., identity, a.s., První certifikační autorita, a.s. and our regional offices. For more information, please contact these institutions.
- II. The first step is to establish a Master Account.
- III. After that the Registration Application must be prepared. It contains basic information about applicant and project. After sending the Application with all necessary appendices, Czechlnvest will perform their material and formal inspection. You (the applicant) and your project will undergo an evaluation of acceptability including an economic evaluation (rating/scoring). The aim of this is to assess whether the project is in accordance with the announced conditions of the programme and whether it fulfils all prerequisites for obtaining aid, according to the conditions of the programme.
- IV. You will obtain information on the evaluation results not later than within two weeks after sending the Application for Registration electronically via eAccount. In the event that your Application for Registration is accepted, Czechlnvest will impart to you the date on which eligible costs arise. From this date, costs expended in connection with the project can be considered as deductible. Applicant can also begin with construction works, sign contracts, order, pay orders etc. After acceptation of Application for Registration the time limit for submission of the Full Application is also defined.
- V. Next step is completion and sending of the Full Application including the required appendices, particularly the business plan, within the stipulated time limit, according to specific requirements of particular programme. Afterwards, Full Application including the required appendices will be inspected. You will receive information on the result of the inspection electronically via eAccount. In the event that the Full Application is correct, the project will be passed on for further evaluation; in the opposite case, the Full Application will be excluded from further evaluation and you will be notified of the reason for its rejection.
- VI. Project evaluation is performed in the regime of small, medium-sized and large projects. Categorisation of projects is determined according to the complexity of the project and the






grant amount. Projects are evaluated on the basis of clearly defined and publicly known criteria. You will receive information on the result of the evaluation via eAccount and you will subsequently be informed of the result of the evaluation in writing. In the event that the project is approved, we will also electronically send to you the Terms and Conditions of Decision to Provide a Subsidy together with a request for their signing and other instructions. The time limit for sending information on the result of the evaluation varies depending on the complexity of the project, whereas it is necessary to take into account that you can be requested to provide missing information about the project, which will probably prolong the evaluation. In the ideal case, the time limit for sending information on the result of the evaluation is estimated for small projects as up to approx. two months from submission of the Full Application and for medium-sized and large projects as up to three months from submission of the Full Application.

VII. The Ministry of Industry and Trade subjects the signed Terms and Conditions of Decision to Provide a Subsidy, which is then sent to the applicant.

Scheme of project administration:




- A ... establishment of the Master Account

The conditions to which the applicant is bound to comply include, in particular:

- conducting of analytical accounting
- selection of suppliers of orders for which aid will be provided from the Operational Programme Enterprise and Innovation in accordance with previously established regulations
- ensuring publicity of projects for which grants are provided, in the form of posters, signs, billboards, etc. during and after implementation of the project in accordance with the established regulations
- division of projects into individual phases according to the schedule of works on the basis of
 previously established conditions (the length of phases is limited by time duration and the
 grant-payment amount)





5. Payment Application and on-site inspection

Aid will be reimbursed to you on the basis of a submitted application for payment. You will submit the Payment Application in electronic form via eAccount following completion of a phase or of the entire project in accordance with the Terms and Conditions of Decision to Provide a Subsidy and with the Project Phase Regulations.

The formally correct and complete application will be passed on to the relevant agency through the process of payment authorisation and, if no deficiencies are found, it will be handed over to the Ministry of Industry and Trade for approval and subsequent reimbursement.

In the course of implementation or finalisation of a project/phase (i.e. following submission of the application for payment) an on-site inspection may be performed at your location.

6. Monitoring the benefits of the supported project

Monitoring of projects is performed in the course of their implementation (i.e. before payment of aid) and following completion of their implementation. The main goal of monitoring is the continual determination of progress in the implementation of supported projects. As an aid recipient, you must keep Czechlnvest apprised of your project in monitoring reports, which you will regularly submit via the eAccount internet application. The indicators that you will include in the reports are stipulated in the Terms and Conditions of Decision to Provide a Subsidy. The monitoring period is three years in the case of SMEs or, in the case of large enterprises, five years for large enterprises following project completion.
